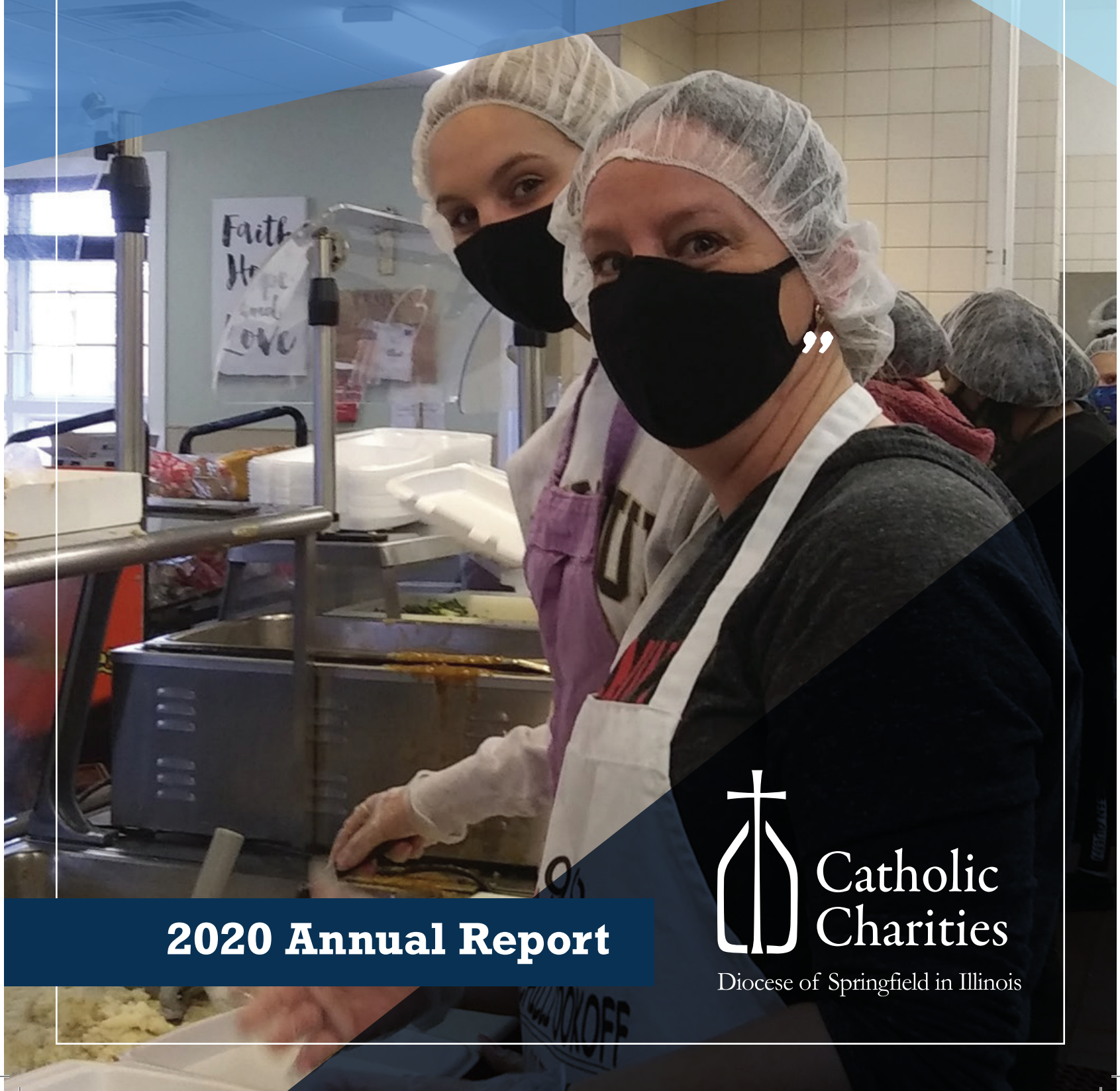

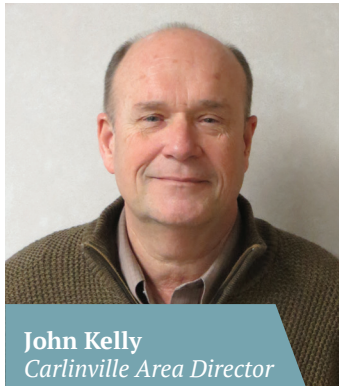
Last year the program served 95 households with legal assistance.

## Decatur Highlights

Decatur Catholic Charities Meals on Wheels program took over the congregate meal program of another agency when they were unable to continue delivering meals due to COVID-19. Within one weeks' time, Decatur Catholic Charities successfully began delivering meals to 150 new clients. Our staff and volunteers made a phenomenal turnaround time to serve these new

clients, and continue to serve them today. These additional 36,000 meals bring our Meals on Wheels program to 109,000 meal deliveries served the last fiscal year. Volunteers in the community also wrote over 3,000 "love notes" to the homebound seniors that were delivered with meals to brighten their day. This program relies on 100 dedicated volunteers each week.

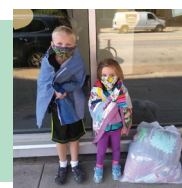
## Quincy Highlights

Quincy Catholic Charities secured grants through the Community Foundation of the Quincy Area, DOT Foods, and the Emergency Food and Shelter Program through United Way of Adams County to purchase meat through two local farmers and a local butcher shop for the Food Pantry and Mobile Food Pantry programs. Quincy Catholic Charities partnered with the Weiman family at Morning Star Farms and Jeff Venvertloh Farms to purchase eight steers over the course of several months. The first steer provided the food pantry with over 400 pounds of meat. The Butcher Block also partnered to provide meat to the Food Pantry when supply was low. Quincy Catholic Charities has become well known for providing a meat/protein option at every food distribution. Due to consumer demands and quantity limits placed on meat purchases at all local grocery stores during COVID-19, no bulk purchasing was allowed at the time, driving up cost and making it increasingly difficult to provide a meat/protein item to our clients. Additionally, the usual donation of meat through Feeding America ceased during the pandemic. Thank you to these local farmers, The Butcher Block, The Community Foundation, DOT Foods and the United Way for partnering with Quincy Catholic Charities to help us meet local needs and build a stronger community.

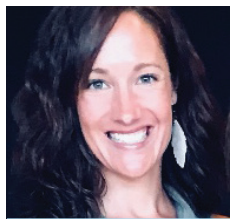

## Springfield Highlights

Springfield Catholic Charities Crisis Assistance Office worked harder than ever to serve those who are struggling and have been negatively impacted by the pandemic. Our staff secured grants to disperse funds to hundreds who needed help with rent, utilities, prescription assistance and other items such as diapers, wipes, and personal hygiene items. The Food Pantry and Mobile Food Pantry combined served ten thousand people combined over the last fiscal year.

The St. John's Breadline began providing 'to go' meals when the dining room was ordered to shut down under COVID-19 directives from the Governor's Office. The Breadline has continued to stay open seven days a week. Last fiscal year the Breadline served 164,005 meals. The St. John's Breadline also hosted two Souper Bowl fundraisers.

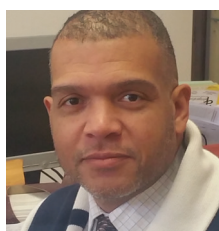
Fifteen Springfield performing arts organizations showed their spirit and generosity over the summer by hosting a food drive for the Holy Family Food Pantry and bringing in three large truck full of food. Additionally, Springfield's Catholic elementary school students gave a staggering 50,000 pounds of food to the food pantry during the fourth annual food drive in October. St. Agnes School came in first place, and Christ the King scored a close second place.

Springfield Catholic Charities was the recipient of new freezers from an anonymous donor. The new freezers allow the Holy Family Food Pantry to expand healthier food options to clients like meat, dairy, fruits and vegetables.

Intact Family Services (IFS), a referral based program that works to keep troubled families together, was blessed with 14 new "Adopt-A-Family" donors through word of mouth from current donors. IFS served an average of 79 families and 161 children year round. An inspirational story from a mother: "Being a disabled veteran, I sometimes struggle to see the light in certain situation, but my caseworker encouraged me to enroll in college, and not be afraid to try. My kids now see me as someone to be proud of."

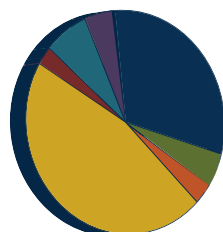
St. Anne Residence continues to provide safe housing for moderate to low-income seniors, with dignity, respect and compassion for all.

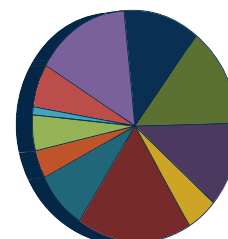

# 2020 PROGRAMS

## **Catholic Charities Legal Services**

This community-based, quality legal services program helps people with little to no income in obtaining pro bono legal assistance in civil matters from area lawyers in specialized fields.

## **Catholic Children's Home**

The Alton-based home provides special education and therapeutic services for students ages 5-21 and residential services to boys ages 11-18. Educational services include programming designed specifically for children with autism.

## **Crisis Assistance**

We provide emergency financial assistance for rent and utilities, as well as providing basic necessities including diapers or hygiene products.

## **Education and Advocacy**

Catholic Charities works with other agencies to find opportunities that will most benefit the client.

## **Eldercare Options**

Assesses, counsels and determines the need for guardianship for the alleged disabled adults who no longer have the ability to make sound judgments on their own behalf. We also strive to find alternative to guardianship as well as secure sound decision makers on behalf of the disabled adults.

## **Elderly Guardianship**

We assume guardianship of seniors and provide decision making and advocacy for elderly adults who lack the ability to make proper judgments concerning their health, well-being and safety.

## **Faith in Action**

Volunteers are matched with homebound seniors, age 55 and older, in Macon County to provide companionship and non-medical assistance. Faith in Action is to help seniors maintain an independent lifestyle in their own homes.

## **Food Pantries**

Our staff serves the nutritional needs of families by helping with immediate problems and searching for future solutions. Donations of food, time and money are necessary in order to respond to local hunger.

## **Health Connect**

Health Connect is a comprehensive intervention program that works with clients who have a high number of hospital emergency room readmissions due to poor health, self-management skills, lack of resources or other social and emotional challenges.

## **Immigrant Services**

Services include financial assistance for green cards, citizenship and naturalization fees as well as coordination of legal assistance.

## **Intact Family Services**

This program's goal is to keep troubled families together by offering them intense case management and education in parenting, and linking them with related services in their communities. This program is referral based only from DCFS.

## **Meals on Wheels**

Lunches are delivered on weekdays by caring volunteers to homebound seniors in Decatur and Macon County.

## **MedAssist**

A prescription medicine assistance program that aids clients with securing immediate or long term medications at free or substantially reduced costs. The following services also fall under our MedAssist program: Senior Health Insurance Program, Marketplace Certified Application Sites, Immediate Meds, the Dental Voucher Program, and Medical Equipment Loan Program. These specific program offerings vary by site.

## **Mobile Food Pantry**

Through this hunger relief effort, a refrigerated truck delivers a supply of food to pre-registered individuals and families in rural communities throughout the Springfield Diocese.

## **Post-Adoption Services**

The Post Adoption program is designed to support and strengthen the lives of adoptive parents, adult adopted persons and birth parents by providing compassionate profiles, searches and intermediary services.

## **Professional Counseling Solutions**

Our therapists offer professional, compassionate services to individuals, couples and families striving for emotional wellness. We also provide counseling to foster children, students and women in crisis pregnancies.

## **Resale Stores**

Our stores are ideal places to find gently worn clothing, housewares and furniture at nominal costs, and much is given away free. Volunteers and community donations help keep our stores going strong.

## **St. John's Breadline**

Operating in Springfield since 1925, our Breadline serves hot and nutritious meals daily at no charge to low income and homeless individuals in our community.

## **Strong for Life**

Strong for Life is a strengthening exercise program designed by physical therapists for home use by older adults (60 and over) to improve strength, balance and overall health.

## **The St. Anne Residence**

A beautiful 23-unit apartment community in Beardstown for low income seniors needing a safe, warm place to call home. The St. Anne Residence opened in 2005.

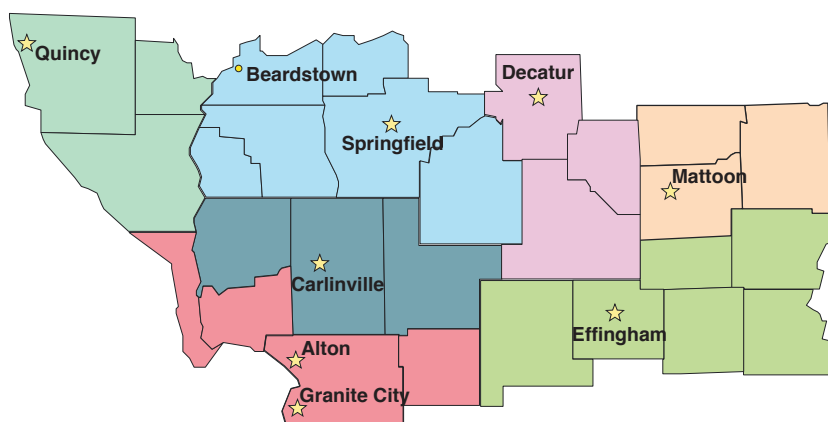
